



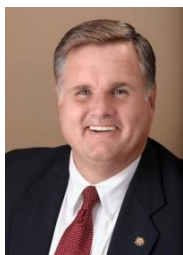

# Douglas County Commissioners: State of the County Update

**Roger Partridge** is the Douglas County Commissioner for District II. Roger's educational background includes a Bachelor's from Purdue University and a double Master's from Arcadia University and West Virginia University. Prior to his election Roger ran his orthopedic physical therapy practice in Castle Rock for 26 years. He has also been a Precinct Person and a District Captain for the Douglas County Republican Party. Roger is the present Chair of the Board of County Commissioners and serves on many outside boards representing Douglas County including:

- E-470 Public Highway Authority
- Denver South Economic Development Partnership
- Douglas County Fair Board
- Denver Regional Council of Governments
- Statewide Broadband Deployment Board

Douglas County Commissioner **Lora Thomas** represents District III. Lora, who's a longtime member of Douglas County Republican Women, kept her promise as the Douglas County Coroner to bring accountability to that Office. Lora served with the Colorado State Patrol for 26 years – she was the first woman Captain and Major, and she has a long history of working collaboratively with other agencies, managing public sector budgets, and developing and implementing public policy.

Lora's volunteer efforts include: Chair of the 18th Judicial District's Victim Compensation Board, President of a non-profit, "A Night with the Coroner" and the Highlands Ranch Community Association. Lora has earned a Finance degree and an MBA from Regis University.

**Dave Weaver** is the Douglas County Commissioner for District I. He was recently named the 2015 Freshman Commissioner of the Year by Colorado Counties, Inc. As a former Douglas County Sheriff, Dave began his service career in the Douglas County Sheriff's Office 33 years ago.

Dave also serves as a representative of Douglas County for organizations including: Arapahoe/Douglas Workforce Development Board; Centennial Airport Community Noise Roundtable; Cherry Creek Basin Water Quality Control Group; Developmental Pathways Board of Directors; Douglas County 9-1-1 Authority; Douglas County Community Services Block Grant Tripartite Board; Douglas County Fair Association; Douglas County Youth Initiative Advisory Committee; Local Emergency Planning Committee; Metro Area County Commissioners; Partnership of Douglas County Governments; South I-25 Urban Corridor Transportation Management Authority. He also serves on many state and national boards.

Weaver's education is rooted in management, ethics, and criminal justice. He is a graduate of the Leadership Program of the Rockies and Leadership Douglas County; a graduate of the Southwest Command School and a graduate of the 91st National Sheriff's Institute. He also is a 2004 honor graduate of the FBI 216th National Academy.

Dave and his wife of 30 years, Mona, have three sons and two grandchildren.

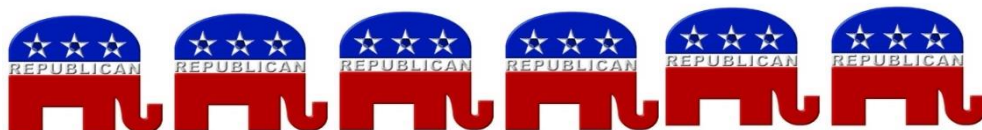

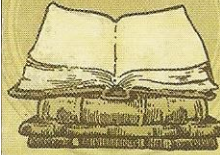

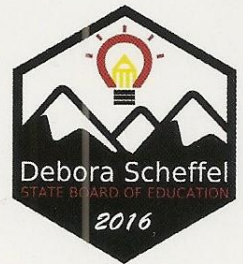
