Don Ytterberg, Senior Advisor, Colorado GOP began challenging public policy more than 25 years ago testifying against proposed EPA regulations at the Old Executive Office Building in Washington, D.C. Since that time he has been a Candidate for the Colorado State Senate and the U.S. House of Representatives. He has served four terms as the Chairman of the Jefferson County Republicans and was twice elected Vice Chairman of the Colorado Republican Party. He holds a B.S. in Industrial Engineering, an MBA, is certified as a Life Coach and is an alumnus of the Leadership Program of the Rockies.

Don is CEO and Owner of Advanced Surface Technologies, a precision metal plating company with over 50 employees located in Arvada. He has served as an Officer and Director of a number of professional, technical and community service organizations, has been an Elder in several churches and was a recipient of the Colorado Environmental Leadership Award.

He and his wife, Kim, live in Golden. They have 5 children and 7 grandchildren.

In July 2008, he created the first Warrior dog-training program to provide a safe, effective, non-pharmaceutical intervention to help treat the symptoms of post-traumatic stress (PTS) and traumatic brain injury (TBI). The program, based at the Palo Alto VA's Men's Trauma Recovery Program in Menlo Park, CA evolved into a highly respected intervention. To date, thousands of Service Members and Veterans suffering from symptoms of combat stress have participated.

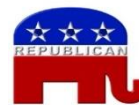

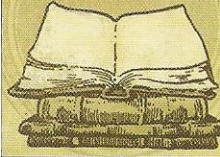

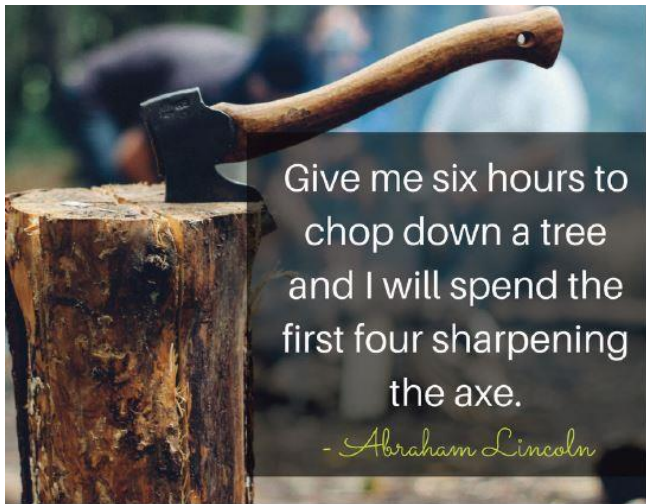
